MEETING MINUTES

WELCOME AND UPDATE

The president welcomed everyone. Since the Board of Trustees has not met since the last Council meeting, there was no update; however, the Board is meeting in Greece next week, thanks to an invitation from the Stavros Niarchos foundation. Reports will be made at the next meeting.

Anika reported that the Alumni Association was well represented at commencement with speaking roles at seven of the nine events. Judy, Sonia and Anika participated in various ceremonies, which were spread out over nine days. It was great to welcome the newest members of the Alumni Association.

She announced that a listening session with president Daniels is scheduled for July 26 at 5 pm; more details will follow.

Mary Ann mentioned that on the capital subcommittee, they continue to focus on the great projects going on on several campuses with construction at Homewood and Pennsylvania Ave. in DC. She will have more to report in October.

SECRETARY'S REPORT

Secretary Judy Keen reported that the bylaws changes were approved by email vote and covered three areas – clarification of donations by the Council members, clarification on nominations to the council, and having an annual review of the bylaws.

She asked for and received approval of the minutes of the April 30 meeting.

COMMITTEE REPORTS

The Alumni Experience

Staff member Will Quinn reported on the lifelong learning aspects of the committee. He noted that since the last meeting, there have been numerous changes with internal staffing and with leaders for this committee. New leaders will be identified to develop a plan to maintain, rebuild and support the structure and activities that are in place. Committee leaders will evaluate the summer and future plans for one of the main activities, Hopkins at Home. There is an opportunity to rethink and rebuild the projects to ensure they align with current world events of interest to the Hopkins community.

Engaging Future Alumni

May Pei reported that they are transferring the awarded grant funds to some of the student groups who had not yet received their funds. The committee is meeting to discuss how to phase in the new student reps and to plan the first networking event in the fall. Given summer schedules, they plan to regroup in August. Regarding ongoing projects, the rings for the caRING program are currently being shipped.

Building Diverse Leadership

Joe Yoon reported that the committee has been focused on two areas; nominating new members and renewing members for a second term. He reviewed the names of proposed new Council members. (See attached list of bios.) Judy asked for a vote and received approval of the list. Joe reviewed the list of those eligible for a second term and noted that so far those asked to serve a second term have all have accepted. (See attached list.) The third activity for the committee is to engage local chapters in building the pipeline for the future.

The question came up about the list of officers and when that would be presented for approval. Anika said that bios of the proposed leaders would be included and the slate presented within six weeks.

Operations

Mike Waters reported that his committee is working on their top priority, engaging members on OneHop, identifying and establishing superusers, and preparing training sessions. The committee's new council newsletter has been well received; another one is set for the end of the month. They are seeking more contributions for the newsletter through summer. An exit interview was held with Council member Eric Brown, who resigned in May. The committee is reviewing the survey results and feedback about onboarding and offboarding and will be making proposals.

Anika noted that she looks forward to learning more about their findings.

DIVISIONAL REPRESENTATIVE REPORT

Susan Kulik began an update on the School of Nursing, but due to some connectivity issues, was cut short. The PowerPoint outlining her report is attached. It was noted that Nursing is ranked number one with both Masters and Doctoral programs and third in the world. This report can be revisited at the next meeting.

ALUMNI RELATIONS AND ANNUAL GIVING UPDATE

In the absence of Susan deMuth, no report was made.

Marguerite reported about the Council's fall annual meeting - October 7 will include the alumni celebration dinner at the B&O roundhouse; Saturday will be at the Carey Business School; Dean Triantis will welcome the group and there will be a tour of the spaces. Friday, October 7 will include a new members orientation and opening session on the Homewood campus with more details to come.

It was asked if there will be a divisional report by Peabody this year. Anika stated that we'll plan on SAIS, Peabody and Nursing at the next meeting. Engineering presented the prior year.

Elena Thompson introduced new OAR staff member Salina Rai, the assistant director of identity and shared interest groups. She is from Nepal and looks forward to working with everyone.
